### **Information we collect**

**Contact information.** We don't collect any of your contact information like name, email, mobile number, phone number, street, city, state, pincode, country and IP address. We might collect your name, email, mobile number if you try to contact us through our "contact us" modal.

**Payment and billing information.** We don't collect your billing name, billing address and payment method, credit card number or credit card expiry date or other details pertaining to your credit card on our website.

**Information you post.** We don't collect any information you post in a public space, or on a third-party social media site belonging to Tan90thermal.com. We do collect the message you post on our "contact us" modal.

**Demographic information.** We don't collect demographic information about you, things you like, things you buy or you intend to buy, or any other information provided by you during the use of our website or any other website.

**Other information.** We collect information like your IP address and the browser you're using.
